## NOTIFICATION

In pursuance of the Order No. 177-CS/2020 dated 18/05/2020 by the Hon'ble Chief Secretary, Government of West Bengal and order nos. 351/HS/PA/20 Dated 7<sup>th</sup> July 2020 and 358/HS/PA/20 Dated 14<sup>th</sup> July 2020 of Additional Chief Secretary, Home & Hill Affairs and P.A Deptts, Government of West Bengal regarding notification of Containment Zone related to outbreak of COVID-19 and as per letter no. 2914/CS dated 20<sup>th</sup> July 2020 of Administrator, Burdwan Municipality regarding proposal for complete lockdown of Burdwan Municipality, there has been rise in number of cases in Burdwan town, especially in last seven days. As on date, there are 48 active corona positive cases out of 63 cases.

Therefore, as per instructions of the Hon'ble Chief Secretary, Government of West Bengal as well as ACS, Home and Hill Affairs Dept, Government of West Bengal all 35 wards of Burdwan Municipality will be strictly under complete lockdown (except the essential commodities and medicine shops as per protocol) from 22<sup>nd</sup> July 2020 for a period of 7 days until further orders.

All necessary standard operating procedures with the following shall be strictly adhered to in the Containment Zone:

- 1. No socio- economic activities permitted.
- Complete access control. Cordoning of the entire unit with complete restriction on ingress and egress. Measures like appropriate barricade, CCTV surveillance, drone/mobile app based tracking and monitoring of restrictions imposed.
- 3. Regular sanitization/cleaning by respective local bodies.
- Dedicated suitably equipped task force for conducting out reach fever mapping and enforcement of restrictions imposed. Intensive testing and contact tracing.
- 5. Organizing home delivery of essential commodities, medicines and health services, wherever required.

6. Appropriately equipped with protective cover e.g. PPEs, masks, the frontline workers will do intensive home surveillance.

This containment zone will be subjected to strict lockdown, and the following activities, inter alia, will be closed in this area:

- (i) All offices, Government and Private
- (ii) All non-essential activities
- (iii) All congregations
- (iv) All transportation
- (v) All marketing/industrial/trading activities.

Residents of the Burdwan Municipality will be exempted and prohibited from attending Government and Private offices. In fact, their ingress and egress will be strictly regulated.

All concerned are hereby informed accordingly.
